As you are aware that the Central Wool Development Board (CWDB), Ministry of Textiles is implementing Integrated Wool Development Programme (IWDP) for development of Wool Sector since 12th Plan period with the help of Central/State/UT Government Departments/Organizations, Animal Husbandry/ Industries Departments, Sheep & Wool Boards/Corps. in all major wool producing/potential areas of the country.

The Ministry of Textiles (MoT) has approved new Integrated Wool Development Programme (IWDP) by rationalization, modification and enhancement of financial provision under existing scheme through SFC approval. MoT has approved the guidelines of IWDP vide above referred letter dated 15th Sept.,2021 for effective implementation of projects with 100% funding pattern. IWDP has following component:

The Guidelines have been prepared with an aim to bring clarity in implementation of schemes and modified according to the demands of the various stakeholders. Following major changes have been made in the new Wool Sector Schemes (IWDP) to ensure their successful implementation:-

1. Funding pattern in the IWDP schemes has been reverted to 100%.

2. New provision has been made for providing Administrative Expenses @ 2% of total project to the concerned Implementing Agencies under IWDP to meet out their overhead expenses to implement the projects in an effective manner.

- 3. Realizing that there is shortage of resources with State Governments Implementing Agencies (IAs) to run the Common Facility Centres (CFCs) and it has been incorporated in the guidelines that the State Implementing Agencies (IAs) may have the option to implement/run the project on contract/lease basis. Also, the component of construction of building for housing the machinery at the cost of not more than 25% of total project cost has been included, which would attract better proposals.
- 4. Effective feedback mechanism has been incorporated in these guidelines so that there is effective flow of information between the implementing Agency (IA), CWDB and Ministry of Textiles.

Detail guidelines for implementation of IWDP (Wool Sector scheme) containing details like eligibility criteria of Implementing Agencies, provision for financial arrangements, project appraisal/approval procedure, release of funds, monitoring & evaluation of projects, projects implementation conditions, sub-components wise allocated budget, Unit Price, Physical Targets, beneficiaries and output outcome indicators is enclosed herewith with along with prescribed format (Annex.-I) to submit fresh project proposal with DPR. The same guideline is also available on web site of CWDB i.e. www.woolboard.nic.in for invitation of new proposals.

As above, it is requested to prepare suitable project proposal as per your requirement under the components of IWDP as per the guidelines under prescribed format as Annex.-I along with the DPR and other supporting documents. Kindly submit fresh project proposals initially for implementation in current FY 2021-22 and 2022-23 to this office as first batch/demand latest by 15th Oct., 2021 for consideration and approval of Project Committee and Technical Committee of IWDP. Soft copy of each new project proposal along with enclosures may also be send on Board's e-mail woolindiajodhpur@dataone.in, separately.






A.- Guidelines for implementation of Wool Sector Programme i.e. Integrated Wool Development Programme (IWDP) from FY 2021-22 to 2025-26.

I. Programme:-

1.1 The Wool Sector Programme of Ministry of Textiles namely 'Integrated Wool Development Programme' (IWDP) is an integrated programme which will be implemented during the period of 15th Finance Commission i.e. from 2021-22 to 2025-26 in all wool producing States as per the approved SFC. Sub-schemes/Component-wise financial allocation for five years under IWDP is as under:

- 1.2. The guidelines contain details of sub-components under the programme i.e. Eligibility Criteria, Budget Ceiling, Allocated Budget, Unit Price, Funding Pattern, Implementing Agencies, Physical Targets, beneficiaries and output outcome indicators and are given separately.
- 1.3 The Nodal Agency for the implementation of Integrated Wool Development Programme (IWDP) will be Central Wool Development Board (CWDB).



- 1.4 For effective implementation of the projects, administrative expenses @ 2% of total project cost would be provided to the Implementing Agencies under IWDP to meet out their overhead expenses to implement the projects.
- 1.5 Administrative and Establishment outlay of Rs. 20 Crore (including in the overall outlay of the scheme of Rs. 126 Crore), as per the breakup given in above table, pertains mainly to the Salary, Allowances, Wages and Statutory payments/dues and Establishment Expenses of the CWDB.

2. Implementing Agencies:-

- 2.1. The Wool Sector Schemes under Integrated Wool Development Programme (IWDP) except R&D sub-component under HRD Component/scheme will be implemented through concerned Central/State/UT Government Departments/Organizations as under:
 - a) Central/State /UT Govt. Sheep & Wool Boards/ State Govt. Corporations/Federations
 - b) Central/State/UT Statutory, Autonomous and Advisory Bodies/Departments
 - c) State/UT/Central Govt. Animal Husbandry/ Industries/Cooperative Departments.
 - d) Central/State/UT Government Departments/Organizations.
 - e) Universities of State/Central Govt.,
 - f) Govt. marketing event organizers e.g. District Industries Centre(DIC), Khadi & Village Industries Commission (KVIC) etc. (for organization of Woollen Expos)
- 2.2 R&D sub-component under HRD Component/scheme will be implemented through following Implementing Agencies as under:
 - a) Central/State/UT Govts. Autonomous/Statutory Bodics/Research & Development Institutions. Textiles Research Associations (TRAs) as approved bodies by Ministry of Textiles for conducting testing, R&D activities related to textiles sector.
 - b) Universities of State/UT/Central Govt.
 - c) Central/State/UT Government Departments/Organizations.

3. Financial Arrangement:

- 3.1 The Ministry of Textiles will place the annual funds to the Central Wool Development Board (CWDB) under one head i.e. Integrated Wool Development Programme (IWDP). As per the SFC Note, IWDP is a Central Sector Scheme for development of Wool Sector, hence funding pattern would be 100% grant from CWDB to the respective implementing agencies for implementation of the projects.
- 3,2 Re-appropriation of allocated funds under schemes/sub- schemes/components/sub-components would be made as per requirement/demand from State/Central/UT Govt. organization/ Implementing Agencies (IAs) with the approval of the Executive Committee of Nodal Agency (CWDB), within the approved SFC limit.

4. Project Proposals:-

- 4.1 In order to seek the financial assistance under components/sub-components of programme, the Implementing Agencies (IA) will prepare Detail Project Report (DPR) as per financial and physical scheme norms containing existing scenario of the project area, methodology for implementation, location, available manpower, infrastructure, expected output and outcome indicators in quantifiable terms and likely employment generation (if any),number of individual beneficiaries, if any, with details such as Aadhar card number, bank account details, PAN card (if applicable), mobile number, their category (SC/ST/Women/General), year wise physical and financial action plan, specification of items, timelines etc. in the prescribed format (Annexure-I) and will submit the proposal (In both hard and soft copy) to CWDB with all supporting documents for consideration of project proposal.
- 4.2 Implementing Agency (1A) should ensure proper backward and forward linkages in the value chain for a balanced growth of the wool sector, while formulating the project proposal.
- 4.3 In case of R&D project, MOU shall be mandatory with the Nodal Agency i.e. Central Wool Development Board for non-disclosure of information and patent, as well as commercialization plan with industry.
- 4.4 Textile Parks under SITP Scheme of Ministry, may submit project proposal for procurement of plant & machinery, testing equipment specific to wool, under various components/sub-schemes of IWDP. The project proposals as per scheme norms shall be forwarded by SPV of concerned Textile Park to CWDB for implementation.

5. Project Appraisal/ Approval & Release of Funds:-

- 5.1 Each individual Project proposal costing up to Rs.40 Lakh would be sanctioned by the Project Committee (PC) for implementation. Project Proposals costing above Rs.40 Lakh and having all the required documents/ information as per prescribed format and fulfilling the criteria of concerned scheme/sub-scheme will be scrutinized by the Project Committee and will be placed before the Technical Committee (TC) for consideration and approval under the chairpersonship Textile Commissioner.
- 5.2 The Technical Committee (TC) of IWDP will approve each individual project proposals requiring financial assistance above Rs. 40 Lakh and up to Rs. Three Crore from CWDB along with approval of year wise fund released. The TC will recommend the each individual project proposals with financial assistance above Rs. Three Crores to Executive Committee (EC) of CWDB.

- 5.7 After approval of projects by the Project Committee/ Technical Committee/ Executive Committee/Secretary (Textiles), Sanction Order for releasing the grant will be issued by the Executive Director, CWDB along with terms and conditions in prescribed installments as per GFR and Scheme guidelines.
- 5.8 Implementing Agency will send the monthly/quarterly Progress Report of the projects containing physical and financial achievements to CWDB. A copy of format to submit progress report by the Implementing Agencies is enclosed as <u>Annexure-II</u>.
- 5.9 All Implementing Agencies will submit Utilization Certificate for the released grant as prescribed under GFR, to CWDB supported by a statement of component-wise physical and financial progress, achievements and inspection report for the funds released along with a request for release of next grant, if any.
- 5.10 The Executive Director, CWDB may incur contingency and statutory dues like rent, electricity & water, telephone, stipend, honorarium, stationery, chemicals, raw material (yarn), taxes for smooth running of Board's own branch Centres at Bikaner and Kullu under HRD component of IWDP scheme within limits of allotted budget provisions for the purpose and will place before next/subsequent meeting of Technical Committee for obtaining post facto approval.

6. Monitoring and Evaluation:-

- 6.1 Each project shall be inspected by a team constituted of minimum two members. Satisfactory inspection report shall be mandatory for release of next installment.
- 6.2 The CWDB shall include members from office of Textile Commissioner/Central Sheep & Wool Research Institute (CSWRI)/ Concerned State/UT Govt. Dept. for inspection. Representative of CWDB would be mandatory.
- Projects up to Rs.40 Lakh shall be reviewed and monitored by Project Committee, Projects above Rs.40 Lakh and upto Rs.3 Crores shall be reviewed by Technical Committee. Projects above 3 Crores which were recommended by EC shall be reviewed and monitored by Executive Committee.
- 6,4 There shall be minimum two meetings of the TC in each Financial Year.

The third party/independent evaluation of the Integrated Wool Development Programme (IWDP) will be done in the last year of the Plan period (FY 2025-26) by an External Agency/ Third Party Evaluation agency.

- The procedural conditions to be followed for implementation of the schemes in the project are as under:
- 8.1 The Implementing Agency (IA) availing support under schemes will be responsible for implementing the project components as per the guidelines and will make efforts to achieve the targets envisaged under the project within the time period mentioned in DPR.

CWDB will place report before the project approving Committee i.e. Project Committee (PC)/Technical Committee (TC)/Executive Committee (EC) and the concerned Committee shall approve the closure of the projects.
- 8.7 Before submission of closure report by the IA, inspection of the project shall be mandatory by a team constituted by CWDB.
- 8.8 All expenditure shall be incurred in accordance with principles/ guidelines of General Financial Rules (GFR) 2017 of Govt. of India and scheme guidelines.
- 8.9 In case of non-implementation of project by IA entire grant shall be refunded to CWDB along with penal interest as per GOI instructions and in case of partial implementation of any project the unspent amount shall be refunded to CWDB along with penal interest as per GOI instructions. Any unspent amount shall be refunded to the Central Wool Development Board (CWDB) after the completion of the project.

1. NAME OF COMPONENT : WOOL MARKETING SCHEME (WMS)

1.1. Sub-component: Creation of Revolving Fund for marketing of raw wool:-

1.1.1. Objective- Sheep breeders belong to an un-organized sector who sell their wool in small volumes. In the present set up sheep breeders are compelled to sell their produce at the prices dictated by traders due to their economic compulsions, low contribution of wool in sheep economy & low volume and distant location of markets. The prevailing system of wool marketing is less beneficial for the sheep breeders and the main share of the profit goes to the middlemen. Therefore, there is a need to procure wool directly from the wool growers on a fixed price by the State Govt. organizations. Financial assistance would be provided to State Govt. organizations for procurement of wool on fixed price directly from wool growers.

- (xi) In case of non-utilization of Revolving Fund more than 12 months, the Implementing Agency shall refund the entire grant amount with penal interest as per GOI instructions, to CWDB. IA has to submit a fresh proposal for further requirement for releasing Revolving Fund with justification to CWDB.
- (xii) In case the State/UT Govt. fails to fix the price of wool in any financial year and no procurement of wool is done, then the revolving fund shall refunded to CWDB and fresh proposal be submitted for revolving fund requirement.



Objective- - In the present set up sheep breeders are compelled to sell their produce at the price dictated by traders due to their economic compulsions, low contribution of wool in sheep economy & low volume and distant location of markets. Normally, the Sheep breeders do not transport their wool to the market and a substantial quantity of wool is purchased by the local traders and / or outside traders at relatively low price. There is need to form wool producer societies/SHGs to increase the bargaining power of wool growers so that the wool producers can sell wool in bulk to fetch better prices. The aim of the subcomponent is to facilitate the IAs to form wool producers societies/SHGs.

1.3.2. Implementing Agency (IA)

- a) Animal Husbandry Departments; Central/State /UT Govt. Sheep & Wool Research Institutes/ Boards/ State Govt. Corp. /Federations. .
- b) State/UT/Central Govt. Departments/Organizations

1.3.3. Conditions

- (i) Group of wool producers (Society/SHG etc.) will be formed by the IA and shall registered them with the relevant Govt. body.

Publicity campaign for woollen stalls including publishing advertisement in newspaper, banners, hoardings, audio-video shows, taxes etc. all expenses included in Rs. 25,000/-.

2. COMPONENT: WOOL PROCESSING SCHEME (WPS)

2.1. Sub-component: Establishing Common Facility Centers (CFCs)

2.1.1 Objective- The Woollen industry suffers from inadequate and outdated processing facilities. The pre-loom and post-loom facilities are required to be modernized for ensuring quality finished product. Quality finishing of the woollen products will not only increase use of indigenous wool but will also make the product more competitive in the international market. It will also assist in procuring better price for wool growers and will make quality raw material available to the Khadi and Handloom sector. Owing to overall size of the woollen industry and specialized nature of equipments required for processing, the industry has been dependent on imported plant and machinery. With this view setting up of Common Facility Centre for all kind of wool and woollen processing facilities like-wool scouring, drying, carding, dyeing, knitting, weaving, felting/non woven, and finishing are proposed to be taken up by the CWDB for the integrated processing of raw wool and woolens in wool producing and wool trading areas. Establishing such plants/centers will increase wool processing capacity and will result in value addition to Indian wool industry and will create more employment opportunities and income generation in the country. Provision for construction of building for housing the plant and machineries has also been made under this component.

2.2.1. Objective- Manual shearing is not only expensive and time consuming but it also reduces the quality of wool in terms of fibre length. While on the other hand machine shearing is cheap, quick and it improves the fiber length. Wool yield per animal also increases approx. by 7-8%. Hence there is need to provide more sheep shearing machine to cover more sheep under machine shearing specially in the hilly states producing fine quality wool. Financial assistance will be provided to procure shearing machines to undertake the machine shearing activity.



Lack of wool testing equipment leads to sale of wool on cheaper rates, therefore, there is a need to set up bale press machines and wool testing equipment either in the wool Mandi or in the existing laboratories of the States/UT. This separate component would provide a comprehensive service package of quality parameters for wool testing equipment, installation of bale press machines to reduce packaging and transportation expenses of wool and creating facilities. 2.4.1. Objective- India is known for its traditional handmade items and demand of these items is high in both international and domestic markets. These items are being manufactured on small tools like handlooms, carpet weaving loom, small knitting machines, spinning charkha (to produce hand spun yarn) etc. Although this can be a source of income in case trained person can have their own equipment, however, these tools are not affordable by the poor. India has a huge young population and to provide them employment opportunities many skill generation programmes are being run by the Government. However, even after skill development training many people are not able to make products due to lack of small tools. Under this component, Handlooms/ carpet looms, knitting machines, spinning charkha etc. would be provided to woollen weavers/artisans in potential areas for value addition of raw wool and manufacturing traditional woolen products at home.





3.3.1. Objective-Manual shearing is not only expensive and time consuming but it also reduces the quality of woolen terms of short staple length. While on the other hand machine shearing is cheap, quick and it improves the fiber length. Despite availability of new sheep shearing machines there is shortage of trained machine shearers to operate the machine resulting low coverage of sheep under machine shearing. To popularize machine shearing in the country, it is required to train sufficient sheep shearers to operate the shearing machines. Under this component financial assistance would be provided to provide Training on machine shearing.



3.7. Sub-component: Wool Survey, Study on wool Sector

3.7.1. Objective -There exists a serious gap regarding available information and statistical data in the profile of wool sector - both in respect of wool growing and manufacturing infrastructure. There is no central point either in the Government or institution levels in the country to maintain and monitor the flow of consolidated statistics and information on trade, import, export, production, consumption, raw material, intermediates and finished goods, number of units in different segments of wool sector. There is lack of data in respect of wool growth, grading, shearing and marketing of wool. Also there is no information available regarding the facilities available at wool growing and processing areas and their further requirements. As such, there is need to evolve a system in where regular flow of information is established, maintained and regulated for dissemination in respect of wool fibre production, industry data on production, consumption data on large and small entrepreneurship in the worsted, woollen, shoddy, handloom, power loom, knitting and khadi sector, etc., from time to time. In this component there is requirement of wool survey of entire wool producing states.



Besides, a Weaving & Designing Training Centre and Industrial Service Centre is being operated at Kullu (H.P.) with the objective of training personnel/weavers engaged in Woollen handloom production activities in hilly and backward areas. They will be trained in the latest designs of handloom weaving with a view to improve productivity and quality of the woollen fabrics. The Board intends to continue this activity during next five years with increase in number of trainee's and up gradation of Centre by installation of diversified machineries.

4.1 Name of Sub-component: Revolving fund for pashmina wool marketing (For UT of J&K & UT of Ladakh)



4.2. Name of Sub-component: <u>Setting of machines for pashmina wool</u> processing (CFC) including construction of building.

4.2.1. Objective- Presently, only scouring and dehairing activities exist at Leh and there is need to set up latest technology scouring and dehairing plant to increase the Dehairing capacity. Apart from this, there is a requirement to move ahead and make Leh as a hub for manufacturing of pashmina products. For this there is a need to establish CFC for pashmina wool processing machines apart from dehairing like- spinning, dyeing, pashmina product manufacturing machines (knitting, Weaving, handloom) and finishing machines for pashmina products including provision for construction of building. The new machines will ensure availability of quality pashmina yarn to local population to produce pashmina products and facility for finishing/dyeing of pashmina products.

4.2.2. Implementing Agencies-

- a) Animal/Sheep/Industries Dept. and any other Govt. agency of UT of J&K/ UT of Ladakh
- b) State/UT Govt. Sheep & Wool Boards/ State/UT Govt. Corporations/Federations

4.2.3. Conditions-

4.3. Construction of shelter shed with guard rooms for pashmina goat.

4.3.1. Objective-Although the Livestock herders of Ladakh, produce one of the finest fibre, they still lead a deplorable life. The Socio- economic, educational housing has remained primitive. Owing to the hostile living conditions, the younger generation once educated never return to Pashmina growing trade. The area witnesses unprecedented heavy snow fall, which results in death of their sheep and goats. This trend adversely affects the economy of not only the livestock rearers of Ladakh as well as of weavers spinners and artisans. As housing lays the foundation for a dignified life for the rural poor, under this component shelter shed with guard room shall be constructed to improve the living condition of nomads and housing of pashmina goats under the project by providing financial assistance.

4.4 Sub-component: Distribution of portable tents with accessories

4.4.1. Objectives-The livestock herders in Ladakh migrate throughout the year with longer stays at some specific locations in search of suitable pasture for their flocks. During migration they face adverse conditions such as severe winter and snowfall. They mostly stay in Yak Wool tents (Rebo) which are not suitable during heavy snowfall. During previous plan, the nomads were provided incentives like portable tents, solar torch and snow boots for facilitating their migration process. But still large numbers of breeders are left uncovered under the scheme which need to be covered.

4.5.- Distribution of predator proof corral with LED lights

4.5.1. Objective-Pashmina Goats in Ladakh are reared in different conditions, ranging from extensive grazing to close confinement. Encounter with wild animals in Changthang results in loss of livestock affecting the pashmina economy. A predator proof coral essentially made of bricks and stone, fortified with chain link meshes on the roof together with a LED based predator warning light will benefit many nomadic villages which are prone to these wild attacks.

Polymerase chain reaction (PCR)-based detection method can be used to identify origin of animal fiber. Component has been kept to establish DNA analyzer lab to authenticate pure pashmina products

4.8. Sub-component: <u>Development of Fodder land/Govt. farms for pashmina goats</u>

4.8.1. Objectives- Scarcity of fodder in the Ladakh region in high, especially in winters. Mortality rate increases drastically during winter when pastures are covered with thick layer of snow. There is need to develop fodder land at different places in the region to ensure the availability of sufficient quantity of fodder throughout the year. The object of the subcomponent is to bring additional community barren land under fodder cultivation through creation of an efficient irrigation facilities and water management techniques. Pasture development in the region shall be undertaken through fencing, creation of irrigation facility and enhance water use efficiency through application of solar power based micro irrigation system.
