I. Location of Services

The Services shall be delivered jointly in Jodhpur, Rajasthan (CWDB HQ) and New Delhi. At least 2 of the proposed 3 team members (to be finalized by CWDB after award of work) shall be based full time in Jodhpur, and 1 shall be based full time in New Delhi, so as to support in coordination with the Ministry of Textiles and other stakeholders. Office space including suitable furniture, internet connectivity and printer shall be provided by CWDB.

II. Technical proposal, presentation and Evaluation criteria

The interested bidders are required to submit their technical presentation (along with detailed CVs of all 3 proposed resources in World Bank format) in line with the below evaluation criteria on eProcurement portal within the due date as indicated. Responsive bidders shall be required to give technical presentation to the officials of Central Wool Development Board on a date and time to be communicated subsequently.

III. Commencement Date and Term

Provision of services under this SOW shall commence from the day of signing of agreement/contract until twelve (12) months (further extendable in tranches of 12 months each based on NeGD empanelment duration) from the date of agreement/contract commencement. A performance review shall be undertaken on a monthly basis with senior representatives of the successful bidder.

V. Method of Selection

The Central Wool Development Board (CWDB) shall award the Work Order to the agency scoring highest marks (H1) against the above-mentioned evaluation criteria, as presented in their proposal/presentation. The financials shall be calculated as per the NeGD empanelment rates as per the above-mentioned profiles/roles. The contract value shall be calculated as follows:

{Man-month rates of profiles X no. of months of engagement X no. of profiles} = Contract Value of the assignment. GST and all out of pocket expenses (as per Clause 7 below) shall be payable at actuals in addition to the fees.

The invited bidders shall be required to make presentation on the same presentation which is uploaded to the procurement Portal.

Note:

- a) The CWDB accepts no liability of any nature whether resulting from negligence or otherwise or inability to participate in the online presentation in the assigned timeslot.
- b) The Applicant shall bear all its costs associated with or relating to the preparation and submission of its Proposal including but not limited to preparation and submission of its presentation.

- c) CWDB reserves the right to select or reject all or any proposal without assigning any reasons whatsoever.
- d) The decision of CWDB in the selection process shall be final and binding on the participating agencies.
- No extension for presentation shall be provided, considering the criticality of the project.
- f) Bid validity Bidder's bid must remain valid for 90 days from the date of submission of the bid.

VI. Terms and Conditions of Engagement

- a) All services under this engagement are to be rendered as per the terms outlined in the NeGD empanelment notification No. F.N. N-22018/33/2022-NeGD dated 17th May 2024. A separate contract shall be signed between CWDB and the winning bidder on mutually agreed terms and conditions, which will form the basis for the project execution and governance. In case of any conflict between the terms and conditions outlined in this RfP, the aforementioned contract, and NeGD Terms of Empanelment, the order of hierarchy shall be (i) Contract; (ii) RfP and (iii) NeGD Terms of Empanelment. Selected firm shall be required to submit a Performance Bank Guarantee equivalent to 5% of the contract value, prior to contract signing. This PBG shall be valid for 15 months (3 months after completion of contract period)
- b) The winning bidder shall be notified through an email/Work Order confirming their result. Winning bidder is expected to convey their acceptance of the work order within 15 days of receipt of the work order. Signing of the agreement should occur within 15 days of Work Order acceptance. The engagement is expected to commence through signing of Contract/ Agreement within 15 days of receipt. The deployment of resources is expected to be initiated within 45 days of signing of the agreement.
- c) The consultant will provide regular updates and reports to CWDB to ensure project milestones are being met.
- d) Details of the contract are as follows:
 - Contract Duration: This contract is valid for 12 months and can be extended further based on NeGD empanelment duration.
 - Contract Fees: All payments shall be made in Indian Rupees and shall be subject to applicable Indian withholding taxes, if any. The total monthly cost of the project as per NeGD rates would remain unchanged until revised by NeGD, MEITY, Gol.
 - Out of Pocket Expenses: Outstation travel (for locations outside Jodhpur/ New Delhi) shall be undertaken as per directions of the CWDB. Reimbursements shall be made as per prevailing rules of the Ministry of Textiles, Government of India (Travel, Stay and Per Diem (inclusive of food and local conveyance) expenses as applicable to Under Secretary level in GOI).
 - Office Infrastructure: CWDB will provide an office space and Further CWDB shall also provide access to suitable meeting room/ conference room on an as required basis. The winning bidder shall equip their team with resources like laptop etc.

- Payment Schedule: Payment will be made monthly upon submission of invoices and Monthly Progress Reports (MPRs).
- SOW: The detailed scope of work, terms and conditions, payment terms etc. shall be mentioned in the contract to be signed between the two parties which will be based on the NeGD empanelment contract, with exceptions if any, to be highlighted. The project shall be executed as per the contract only and in case of any conflict between clauses of the executed contract, and NeGD empanelment contract, that of the executed contract with CWDB shall prevail. This RFP/ TOR, the work order resulting from this TOR and acceptance shall form the part of the contract.
- Limitation of Liability: Limitation of liability shall not exceed the fee paid to consultant/bidder
